Discussion/Action Complaint on the new guard rail at the end of East E. Street

The board has received two complaints regarding the Guard Rail installed at the end of East E. Street. Ed brought up the issue about the guard rail to Bauer during a walk through and what we were wanting in that area, but the current guard rail cost the town \$1,000. Bruns will contact Scott for JEO and see what can be done with the current guardrail.

Discussion Street Project

Bauer construction crew chipped the concrete on the sidewalk by the bank. The bank had them cut back 6 feet on the sidewalk to have it tie in the right way and will backfill the sidewalk area. Bauer is planning to start planting grass tomorrow. Pavers will be laying asphalt Thursday or Friday. Ed and Jeff will be present for the final Street project walk through next Friday, November 13,2020.
